SUBJECT: Review and Approve a Natural Playground Design and Construction Services

Agreement with Natural Playgrounds Company, LLC, in an Amount Not to

Exceed \$178,000.

RECOMMENDED ACTION:

Approve a natural playground design and construction services agreement with Natural Playgrounds Company, LLC, in an amount not to exceed \$178,000 (\$23,200 for design and \$154,800 for construction & equipment installation) and delegate execution authority to the Board Chair and Executive Director.

REASON FOR RECOMMENDED ACTION:

Background: Durham Construction was awarded the General Contractor contract to build the Lighthouse for Children (LFC) facility in November of 2013 and construction began in January 2014. Based on the General Contractor's timeline, the Information Technology Contractor was approved by the Board on February 26, 2014. The next component of the construction timeline is the construction of the outdoor natural playground (ONP) area of the facility. The construction and equipment installation of the playground must align with the General Contractor's timeline for the final construction of the perimeter block wall surrounding the ONP.

Staff released a Child Development Center Outdoor Natural Playground Request for Proposal (RFP) on January 10, 2014. The RFP requires the ONP contractor to work with the construction team and early childhood & education experts from the community on the design and construction of the playground. The playground area is approximately ten thousand (10,000) square feet. This includes 1,000 square feet for the required Safe Dispersal Area and 9,000 square feet of divided ONP for infant, toddler and preschool age children.

The California Department of Social Services Child Care Center General Licensing requires child care facilities to have at least 75 square feet per child of outdoor activity space based on the total licensed capacity. The LFC Child Development Center is designed to be licensed for 90 children. Additionally, the RFP required a comprehensive package to be submitted including:

- 1. Design Services
 - Compliance with the Americans and Disabilities Act (ADA)
 - Delineation between 3 play areas
 - 1) Infants (3 24months)
 - 2) Toddlers (24 36months)
 - 3) Preschool (3 to 5 years olds)
 - California safety and licensing standards

- Meet National Association for the Education of Young Children Early Childhood Program Standards and Accreditation Criteria
- Designed to be developmentally appropriate, cognitively challenging, physically demanding, and encouraging of a fully integrated curriculum
- Create a design that is aesthetically appealing, indigenous, sustainable, attractive to wildlife, green, and environmentally friendly with a very low carbon footprint
- Designed to promote: large motor experiences such as running, climbing, balancing, riding, jumping, crawling, scooting or swinging, dramatic play and art

2. Design and Construction Documents

- Milestone A Pre-Design Meeting, Discussion of the scope, budget details, schedule and formulation of a preliminary concept
- Milestone B Conceptual Layout, Prepare and display draft concept plan showing layout, equipment, and major aesthetic elements
- Milestone C Final Design Progress Meeting at 75% Design Development,
 Submit the design developed to 75% to construction team for review
- Milestone D Finalize Design, Submit the final design to construction team for review
- Milestone E Construction Schedule, Submit a construction schedule to general contractor to coincide with the LFC Phase 1 construction schedule

3. Playground Construction Services

 Provide complete contractor playground construction services to develop the space as provided in the design plans and specifications

Procurement Procedure and Process: Two (2) proposals were received and both met the minimum standards to be forwarded to members of the RFP review committee. The committee consisted of the Assistant Director of the Joyce M. Huggins Early Education Center, located on the CSU Fresno campus, Head Start Director of the Fresno Economic Opportunities Commission, and First 5 Fresno County Program Officer.

The selected proposal was Natural Playgrounds Company, LLC. The company has designed over 150 natural play environments ranging in size from 3,000 square feet to 180 acres for children of all ages, including accessible natural play areas for children with disabilities. The company is also the only landscape contractor in the United States focusing solely on the construction of natural playgrounds, and is familiar with all the American Society for Testing and Materials (ASTM), Consumer Product Safety Commission (CPSC), Americans and Disabilities Act (ADA), age-appropriate specifications and guidelines required to construct a safe, accessible, natural play environment. Their experience and knowledge with age specific outdoor natural play areas enables them to meet the LFC board's requirements to create three developmentally appropriate playground areas.

FISCAL IMPACT:

If approved, the recommended amount, not to exceed \$178,000, will be allocated from the approved Lighthouse for Children Facility Budget – Hard Cost Site Work (Playground, Landscape) line item.

FUTURE IMPLICATIONS:

If approved, Natural Playgrounds Company, LLC will work with the LFC construction team to design and install the child development center outdoor natural playground infrastructure and equipment within the construction phase timeline.
